**No. 18/4/2017-3C1:-** In pursuance of the provisions of Rules-10 of the Haryana Municipal Corporation Delimitation of Ward Rules, 1994 and with reference to Haryana Government, Urban Local Bodies Department notification no. 18/4/2017-3C1, dated 13<sup>th</sup> January, 2017, the Governor of Haryana in supersession of all previous orders/ notifications issued in this behalf, hereby publish the delimitation of wards of **Municipal Corporation, Gurugram, District- Gurugram** as under :-

**Schedule of Boundaries**

**Ward No. 01 :-** Starting from the point of Delhi-Haryana Border where the Western-Northern limit of Municipal Corporation, Gurugram intersects with revenue boundary of Village Bajghera, Village Bijwasan and khasra no. 1// 5, Village Choma (X:77.029755 Y:28.531777), thence towards East along with Delhi-Haryana Border and revenue estate of Village Choma up to the point / junction where it meets with Northern corner of Northern Periphery Road (NPR) (X:77.03472 Y:28.529778), thence moving towards South along with NPR up to the point where NPR intersect with Road leading from Palam Vihar to Village Bajghera i.e. Bajghera Road (X:77.023906 Y:28.517614), Western corner of Puri IT Park, including localities Sector-113, thence moving towards East along with Bajghera Road, Police Check Post, Bajghera Chowk, up to the point where Bajghera Road intersect with Railway Line i.e. Bajghera Fatak (X:77.026906 Y:28.507968), thence towards South along with Railway Line, Sarai Alwardi Fatak, leg 2 drain up to the point opp. house of Sh. Chander Singh, Swaroop Garden, Gurugram (X:77.013 Y:28.493), thence moving towards West up to North - Eastern corner of house of Sh. Santosh Bhardwaj on Rajendra Park-Bajghera Road (X:77.010618 Y:28.494234), along with old MC limit dividing Rajendra Park (Mahalwara Estate) up to khasra no. 40, in the revenue estate of Village Gurugram where it intersects with South-Eastern corner of NPR (X:77.004116 Y:28.496902), thence moving towards South along with NPR and Western Boundary of Rajendra Park (along Old MC limit) up to khasra no. 43, Village Gurugram (X:77.002147 Y:28.494864), thence moving towards West along with old Municipal limit and revenue boundary of Village Gurugram up to khasra no. 55, Village Gurugram, thence moving towards North along with the revenue boundary of Village Gurugram and Village Daultabad up to khasra no. 1, Village Gurugram (X:77.00162 Y:28.499252), thence moving towards West along with revenue boundary of village Pawala Khusrupur & Village Daultabad up to the point where revenue boundaries of village Daultabad, Pawala Khusrupur & village Babupur meets at khasra no. 20// 12/1, village Pawala
